**Commitment:** ➤ To board for at least one season (3 months) with M&M.

**Seasons:** ➤ Fall (Sep/Oct/Nov), Winter (Dec/Jan/Feb), Spring (Mar/Apr/May), Summer (Jun/Jul/Aug)

**Payment Plan:** ➤ You will receive an invoice for 3 months when you purchase the season pass.  
➤ We require 3 post-dated cheques for the season – one cheque for each month of the season.  
➤ All 3 cheques have to be in the office no later than the 20th of the month preceding the beginning of the season (Aug 20; Nov 20; Feb 20; May 20).  
➤ Each cheque can be dated for **the 1<sup>st</sup> of the month** in which it is due.  
➤ A late fee of \$25.00 applies to payments received after the above due date and to NSF cheques.
